SHADOW VALLEY MASTER SITE PLAN






Phase 10 Master Site Plan

Phase 10 Frequently Asked Questions



1. When will building start in phase 10?

As soon as the final plat is filed with the City of Rogers. I expect that to be mid to late April of 2020.

2. Is phase 10 gated?

Yes, all of Shadow Valley is a private gated community.

3. How can I tour Phase 10 and SVCC?

I am available to give tours of SVCC and phase 10. I will discuss the attributes of each lot to make sure we are picking the best one for you.

4. How do I purchase a lot or have one held?

At present lots are being purchased by clients for custom homes. Once we find a lot for you, I will make the arrangements to have the lot held while we work towards a start date. The lot can only be held for a few days before it would need to go under contract, but you will have ample time to decide.

5. Are there POA dues?

Yes, the same as the rest of Shadow Valley. At this time, POA dues are currently \$55.00, paid monthly.

6. Do you have to become a member at Shadow Valley Country Club?

Yes, you get to choose from 1 of 3 types of memberships: Social, Tennis, or Golf. Initiation fees and monthly dues for all memberships can be found at www.shadowvalleyinfo.com or just ask me and I will get you the information.

7. Do you have to pay an initiation fee for your membership?

Yes, the one-time initiation fee is paid when you close on your lot and at that time your membership to Shadow Valley Country Club begins and POA dues are collected each month. For monthly dues & POA information, please visit www.shadowvalleyinfo.com

8. Are there any food minimum charges or assessments?

Members only pay their dues for their particular membership each month.

9. Are there covenants and architectural control committee requirements?

Yes, and I can answer any questions you might have and/or provide copies of that information.

10. If I purchase a lot, how long can I wait to build?

There is not a timeline on when you have to build after you purchase a lot. You do have to join the country club and pay POA dues once you close on the lot.

11. How do you get to the clubhouse from phase 10?

- A. You can drive and enter from the new private RFID gate off W. Pleasant Grove Road to enter Shadow Valley, which is a very short distance from the phase 10 entrance.
- B. If you lease a community cart from Shadow Valley Country Club there will be access to the clubhouse without getting on a public road.

12. Will there be a subdivision pool in phase 10?

No, but residents will have full access to the pool and all other amenities throughout the existing subdivision. Of course building a pool at your home is allowed.

13. Is phase 10 in Bentonville School district and what high school would my kids attend?

Yes, and Bentonville High School is where your children would attend.

14. Is there square footage minimum to build?

No, we do not have minimums but plans have to be reviewed and approved by the SVMPC Architectural Control Committee.

16. Are you set up to be able to help clients who can't be there in person to look at lots?

Yes, I can send just about all printed material electronically. I also can provide drone footage and pictures of lots, views, and surrounding areas for you and your clients.

17. When folks move into their new home in phase 10 are there daily time frames on when construction can take place?

Yes, SVMPC has daily timeframes that construction can be done along with guidelines on job site cleanliness.
